Subject:

Provisional Appointment to the post of Medical Officer in Health Department Haryana.

On the recommendation of the Departmental High Powered Selection Committee, the Governor of Haryana is pleased to offer the appointment as Medical Officer to the following doctors in the Health Department, Haryana on purely provisional basis subject to the conditions mentioned in Chief Secretary, Haryana letter No. 52/08/2022-3GS III, dated 23.06.2022, in FPL-10 as per 7th pay commission starting Rs. 56100/- per mensem plus other allowances as admissible from time to time. The following selected Doctors are also hereby posted at the station mentioned against their name.

This appointment is further subject to the following conditions:-


1. In case if your certificate/ documents are found to be bogus at any stage, your candidature will be cancelled automatically without any notice/ intimation.
2. They will be entitled to draw such allowances and other benefits as sanctioned by the Government of Haryana from time to time.
3. The post is temporary and your appointment will be terminable on one month notice on either side while you are in the temporary cadre. This condition however, will not be applicable in case your services are dispensed with during the probation period if, his work or conduct has not been satisfactory.
4. You will be on probation for a period of two years from the date of joining which can be extended, if necessary up to three years. The services put in against the temporary post might be counted towards the period of probation but the completion of two years temporary services will not in itself entitle them to confirmation unless the post is substantively vacant. Their appointment during probation period can be terminated without assigning any reasons or giving any notice.
5. If so required, you shall be liable to serve in any Defence Service or post connected with the Defence of India for a period not exceeding four years including the period spent on training if any, except:-
 - (a) After the expiry of ten years from the date of appointment and
 - (b) After attaining the age of forty five years.
6. You will be governed by the Haryana Civil Medical Services (Group A) Service Rules, 2014 as amended from time to time. In respect of pay, pension, leaves and all other matters not expressly provided for in the Health Department Haryana Rules, you shall be governed by such regulations and rules as have been/would be framed or may hereafter be adopted by the Competent Authority under the Constitution of India.
7. On appointment/joining you will be required to take an oath of allegiance to the Constitution of India.

8. You will be required to submit an undertaking alongwith the joining report
 - A declaration attested by First class Magistrate to the effect that you have only one living spouse and are not married to a person already having one living husband/wife.
 - A declaration that you were not dismissed from service on any occasion under any department of Govt. or convicted by a court of law.
 - In case, you are married, you will have to file a declaration that you did not give/accept dowry during the marriage. If you are unmarried, you will have to furnish a declaration immediately after marriage regarding non acceptance/giving of dowry by you as per declaration in Annexure A and B in terms of Government instructions issued vide No. 18/1/2004-2GSI dated 21.02.2006.
9. Your seniority will be determined according to their position in the merit list sent by the Departmental High Powered Selection Committee.
10. You are liable to be transferred anywhere within or outside the State of Haryana.
11. You are required to furnish a Medical Certificate of fitness before joining from the Medical Board constituted under Rule 9 of Haryana Civil Services (General) Rules, 2016. You should appear for medical examination in the office of any Civil Surgeon of Haryana State.

In case you have already appeared before the Medical Board in Haryana during the last 06 months and are declared medically fit, they need not to appear for the same. In case you are already employed somewhere on a gazette post under the Haryana Government and they have already produced a medical certificate to the department, you may be exempted from producing fresh medical certificate provided there is no break in the service and you have produced the certificate from your employer.
12. The appointment is provisional and is subject to the verification of academic qualification certificate/ Schedule Castes/ Backward Classes/ ESM/ DESM/ EWS/ DFF certificate or any other document/declaration. If the verification reveals that the claims belonging to academic qualification/other documents as the case may be, are false, your services will be terminated forthwith without assigning any further notice and without prejudice to such further action as may be taken under the provisions of Govt./the Indian Penal code for production of false documents.
13. This offer of appointment is further subjected to condition of verification of character and antecedents. In case it is found that the appointee is not of good character and anything is adverse against him/her, his/her services will be dispensed with at once without any notice to him/her in this regard.
14. If the conduct during Probation Period is not found upon the mark the services will be dispensed with during Probation Period.
15. If you are willing to accept this offer of appointment on the above mentioned terms and conditions, you should report to the concerned Civil Surgeon for joining at their respective posting stations within 15 days. No extension in joining time would be allowed. If you fail to report for duty within the stipulated period, it will be presumed that you are not willing to accept this offer of appointment and your candidature will be treated as cancelled.
16. Your appointment is subject to and without prejudice to given undertaking as under as per Chief Secretary Instructions on 52/08/2022-3GS-III dated 23.06.2022:
 - a. Attestation form.
 - b. Self declaration.

Note: The appointees would not be entitled to any claim/benefit because of anything essential regarding Rules & regulations left to be quoted in this letter due to any clerical mistake/error.



Further you are directed to collect all the original certificates/ documents at the time of joining such as academic qualification, SC/BC/ESM/DESM/PH etc. and any other certificate on the basis of which he/she has claimed selection.
