The Governor of Haryana is pleased to give the benefit of life cover to the various employees of the Health Department who are engaged in addressing the situation arising out of COVID- 19, as under:-

- (i) The benefit of life cover of Rs.50 lakhs against COVID 19 announced by the Government of India will be given to all doctors, nurses and Group "C" and Group "D" employees posted in various COVID isolation wards, COVID ICU and COVID OTs across the State.
- (ii) All government employees whether regular, part time or contractual, working in various containment zones including ASHA workers will also be provided an ex-gratia of Rs. 10.00 lakhs against loss of life due to COVID 19 till June 30, 2020.
- (iii) The ex-gratia amount would be defrayed from the Haryana Corona Relief Fund.
