**Subject:- Additions/Amendments/Substitutions in New Empanelment Policy.**

Sir/Madam,

In continuation of the empanelment policy issued vide no. 2/56/2017-IHB-III dated 08.06.2017 and its amendment issued vide no. 2/56/2018-IHB-III dated 20.03.2018 the following additions/amendments/substitutions in the clauses therein are hereby under:-

A.i. shall be substituted as

1. **Multi Speciality Hospitals:-**

- Only hospitals having Entry Level/Full NABH/JCI certificate with bed strength of more than 50 inpatient beds will be considered for empanelment.
- Multi Speciality Hospitals within the Haryana State, with bed strength of more than 50 inpatient beds, must be registered under 'The Haryana Clinical Establishment (Registration & Regulation) adoption Act, 2018'.
- Multi Speciality Hospitals outside the Haryana State must be registered under Clinical Establishment Act, wherever applicable.
- Hospital shall apply on an application form (Annexure-I, Vide Letter No. 2/56/2017-1HB-III dated 08.06.2017) to the Director General Health Services Haryana who will send the proposal to State Government for approval.
- The hospital shall provide renewed NABH/JCI certificate within three months of the expiry of the previous certificate. If they are unable to provide such certificate then it will be de-empanelled automatically.

2. **Single Speciality Hospital:-**

- Hospitals having Entry Level/Full NABH certificate with bed strength of more than 10 inpatient beds will be considered for empanelment except single speciality hospital like Eye, ENT and Dental.
- Single Speciality Hospital including Eye, ENT and Dental shall be empanelled as per the empanelment criteria notified under Ayushman Bharat Scheme at District level. However, the final approval/denial of empanelment of private health facility shall be done by the State Government.

- Hospital shall apply on an application form (Annexure-I, Vide Letter No. 2/56/2017-1HB-III dated 08.06.2017) to the Director General Health Services Haryana who will send the proposal to State Government for approval.
- The hospital shall provide renewed NABH/JCI certificate within three months of the expiry of the previous certificate. If they are unable to provide such certificate then it will be de-empanelled automatically.


D. The hospital must give consent for providing Limited Cashless Medical Facility notified by State Government dated 20.11.2017 and amended 04.04.2018. That all hospitals accept the existing 152 package rates fixed by Haryana Government dated 21.05.2015 now and as revised from time to time. Hospital must give consent to all guidelines of empanelment policy.

E. Any private hospital, if it gets disqualified/de-empanelled under 'The Haryana Clinical Establishment (Registration & Regulation) adoption Act, 2018'. shall be automatically de-empanelled from the list of Haryana Government. No separate intimation/notice shall be issued.

F. In case of a hospital empanelled under both PMJAY and Government of Haryana Empanelment Policy, if that private hospital empanelled under Pradhan Mantri Jan Arogya Yojna (PMJAY) is de-empanelled from the list of services under PMJAY, it shall be de-empanelled from list of Haryana Government as well.


This policy will come into force from the date of issuance.
