Under the provisions of Rule 9(2) of Haryana Civil Medical Services (Group-A) Rules, 1931 amended from time to time, the Governor of Haryana is pleased to promote **Dr. Govind Ram Gupta, Dr. Yogesh Sharma and Dr. Rekha Singh, Senior Medical Officers** to the post of **Civil Surgeon/P.M.O./Deputy Director (S.S)** in the pay scale of **37400-67000-PB-4+Grade Pay 8700/- +NPA** and other allowances admissible from time to time with immediate effect with "subject to the condition as and when officer on deputation in Delhi/Chandigarh on ex-cadre post joins the Health Department, then junior most promote will be reverted without any notice".

2. The officers promoted shall be on probation for a period of one year which is extendable upto three years from the date of their joining the new assignment as per **Haryana Civil Medical (Group A) Rules, 2014**.

3. The promotion shall be without prejudice to the right of their seniors.

4. The promotion is subject to the integrity being certified in respect of ACRs of some years of these officers.
