

Regarding issuance of Provisional NOC to Dr. Sanjay Mehra, Medical Officer, CHC Jullana (Jind) for doing PG Course MD/MS/Diploma (NEET) in PGIMS, Rohtak/any Govt./Private medical College (recognized and approved by Medical Council of India) during Session-2018.

उपरोक्त विषय पर आपके पत्र क्रमांक 78/S(3917)2E-II-2019/CFMS-9676, dated 01.04.2019 के संदर्भ में।

2 माननीय उच्च न्यायालय के आदेश दिनांक 01.04.2019 (in CWP No. 8731 of 2019-titled as Sanjay Mehra Vs. State of Haryana and Ors.) की अनुपालना में सरकार द्वारा Dr. Sanjay Mehra, Medical Officer, CHC Jullana (Jind) को PGIMS, Rohtak/any Govt./Private Medical College (recognized and approved by Medical Council of India) से PG Course MD/MS/Diploma (NEET), Session 2019 करने के लिये Provisional NOC सरकार द्वारा जारी पी0जी0पोलिसी क्रमांक 2/123/2005-1एच0बी0-1 दिनांक 19.03.2018 की शर्तों अनुसार प्रदान की जाती है तथा यह Provisional NOC इस केस के अन्तरिम/अंतिम निर्णय पर निर्भर होगी।

3. यदि अधिकारी का चयन उक्त कोर्स के लिए हो जाता है तो पी0जी0 पोलिसी क्रमांक 2/123/2005-1एच0बी0-1, दिनांक 19.03.2018 के अनुसार उन चिकित्सा अधिकारियों को निम्न शर्तों की पालना करनी होगी :-

1. The Officer will do PG course as per PG Policy dated 19/03/2018 in 20 streams with pay and the Officer will deposit the stipend in the state Treasury which he gets from the concerned institute.
2. Before relieving from the department, for the PG Degree/DNB/Diploma Courses with full salary, doctor shall execute a service bond to the effect that he/she will serve in the health institutions under HCMS/HCDS cadre of Haryana or wherever the deputation quota of HCMS/HCDS cadre exists for a minimum period of 7 years after completion of PG/DNB Course and in default thereof to pay an amount of ₹ 50 Lacs to the State of Haryana. Similarly in the case of Diploma courses for a minimum period of 5 years and in default thereof to pay an amount of ₹ 35 Lacs.
3. In case of violation of policy and provisions of bond, the respective amount of Bond Money shall be deposited by the executor from the date of default and interest of 12% per annum will be charged till its realization.
4. In case the doctor violates the bond the office of Directorate of Health Services, Haryana, Panchkula will write to Haryana Medical/Dental Council/Medical Council of India/Dental Council of India to cancel the registration of the concerned doctor.
5. The qualifying doctor will have to deposit his/her original bachelor degree and the bond while making a request for relieving along with application in the Directorate. An endorsement will be made to the concerned College/Institution/University to deposit the PG Degree/Diploma/DNB certificate directly to the directorate after completion of course. The original degrees will be released after completion of the bond period or deposition of requisite amount with interest. This condition shall be made a part bond agreement.
6. In case the person fails to complete the course of study within the prescribed period, he/she may be allowed to avail chances as per concerned University Rules, to complete the same. The additional time period taken in completion of the course beyond the prescribed period can be allowed as EOL without pay but this extended period of EOL will not be counted as service for any purposes e.g. increments, grant of higher standard scales linked with service period etc.
7. In case the employee concerned leaves the courses of study mid-way without completing the same, he/she will be liable to refund the amount to the Government which he/she has received as salary and the period from the date of relieving from the Government service till the date of joining shall be treated as period of Extraordinary Leave without pay. Further, this period of EOL shall not be counted as service for any purpose e.g. increments, ACP, grant of higher studies scales linked with service period, pension etc. The concerned doctor will also be debarred for a period of 5 years for granting NOC for higher studies from the date of his/her rejoining in HCMS cadre.
8. In case the employee concerned leaves the courses of study mid-way due to such illness/disability so as to render him or her unable/unfit to pursue the course, then the penalty clause may not be applicable. The exemption from penalty clause will be subject to the medical certificate justifying inability to complete the postgraduate course on medical ground by Medical Board constituted by DGHS at Panchkula and the final decision in this regard will be taken by the Government.
9. Change of stream for doing PG degree is not allowed to the doctor who has completed diploma in particular stream as in-service candidate. Those doctors who join the department with diploma can choose stream of their choice but not out of the streams mentioned in this PG Policy subject to the fulfillment of the eligibility conditions as mentioned above.

10. The candidates, who get selected in the diploma courses against the reserve seats for HCMS cadre in PGIMS Rohtak/other Government Medical Colleges of Haryana, shall be considered in-service candidate with protection of salary or without salary as per the fulfilment of the eligibility conditions (1) & (3) respectively. The bond for such diploma candidates will be 5 years or ₹ 35 Lacs/4 years or ₹ 25 Lacs depending as per the eligibility of the candidate for doing the course with full pay or without pay respectively as mentioned above in the policy.
11. In case doctor after acceptance of PG Course, change PG Stream in 2nd and 3rd counseling the period of joining of first stream to joining of other stream and due to his/ her illness during PG Course, the over-stay period will be treated as Leave of the kind due.
12. No Earned and Half pay leaves will accrue to the record of the HCMS/HCDS doctor during the period of post graduation.
