

BOND FOR TEMPORARY GOVERNEMENT EMPLOYEES

PROCEEDING ON STUDY LEAVE

KNOW ALL MEN BY THESE PRESENTS THAT I _____ Son/Daughter of _____ Resident of _____ in the district of _____ at present employed as **Medical Officer** in the Department of Health, Haryana and posted at _____, now undergoing PG degree/diploma in _____ department of _____ Institute (hereinafter called the obligor) and Shri/Smt _____, Son/Daughter of _____ Resident of _____ and Shri/Smt _____, Son/Daughter of _____ Resident of _____ (hereinafter called the sureties) do hereby jointly and severally bind ourselves and our respective heirs, executors and administrators to pay the Governor of Haryana (hereinafter called the "The Government") on demand the sum of Rs. _____ (Rupees _____) together with interest thereon from the date of demand at Government rates for the time being in the force on Government loans or, if payment is made in a country other than India, the equivalent of the said amount in the currency of that country converted at the official rate of exchange, with all cost between attorney and client and all charges and expenses that shall or may have been incurred by the Government.

WHEREAS the obligor is granted study leave by the Government from _____ to _____;

WHEREAS for the better protection of the Government, the obligor has agreed to execute this bond with such condition as hereunder is written;

AND WHEREAS the said sureties have agreed to execute this bond as sureties on behalf of the above bounden;

NOW the condition of the above written obligation is that Dr. _____ before his/her reliving from the department for study, he/she will have to deposit his/her original bachelor degree in the office of DGHS and after completion of P.G. course, the original P.G. degree will be deposited till the bond period completes.

IN THE EVENT of the obligor Dr. _____ resigning from service, without returning to duty after the expiry or termination of the period of study leave or any time within a period of _____ years after his return to duty, the obligor and the sureties shall forthwith pay to the Government as may be directed by Government on demand the said sum of Rs.

_____ (Rupees _____) together with interest thereon from the date of demand at Government rates for the time being in force on Government loans.

NOW the condition of the above written obligation is such that if the obligor shall return to the duty after the expiry or termination of the period of said training and shall serve the Government in H.C.M.S. Cadre for a period of _____ years after his/her return to duty, then the above written bond shall be void but otherwise it shall remain in full force and virtue.

And now in case obligor breach the terms and conditions of Bond, recovery of bond money will be effected by putting the below mentioned property on attachment, sale etc.

AND upon the obligor Dr. _____ and/or Shri/Smt. _____ and, or Shri/Smt. _____, the sureties aforesaid, making such payment the above written obligation shall be void and no effect otherwise it shall be and remain in full force and virtue.

PROVIDED ALWAYS that the liability of the sureties hereunder shall not be impaired or discharged by reason of time being granted or by any forbearance act or omission of the Government or any person authorized by them (whether with or without the consent or knowledge of the sureties) nor shall it be necessary for the Government to sue the obligor before suing the sureties Shri/Smt.
