

## OFFICE ORDER

The following class-IV employees of the Subordinate offices of the Health Department, Haryana are hereby provisionally promoted to the post of ECG Technician in the pay structure of Rs. 5200-20200+2400GP w.e.f. from the date of their joining to the said post of ECG Technician. As a result of promotion they are posted in the offices mentioned against each. This promotion is also subject to the following conditions:-

They will not claim seniority above their seniors, who have not been promoted at present due to disciplinary proceedings under Rule-7 of punishment and Appeal Rules pending against them or for want of completion of record on the basis of their present promotion and they will be reverted to the post of Class-IV without giving any notice. If any senior to them is/are found fit for promotion to the post of ECG Technician later on or in the event of decision in their seniority position made by the Department/Court and their inter-se-seniority will not be disturbed.

The promotion is subject to the condition that in the event of final decision in the disciplinary proceedings, which are pending against their seniors, they shall have no right above them on the post of ECG Technician.

That they will be probation for a period of one year and if their work and conduct during the period of probation is not found satisfactory they will be reverted on the post of Class-IV without giving any notice thereon.

The above promotion are without prejudice to the decision to be taken by the Hon'ble Supreme Court/High Court in SLP/CWP pending in the courts about reservation in the promotion case.
