Sub:- Liberalization of delegation of powers with respect to advance and reimbursement of Medical Claims of Haryana Government employees/pensioners and their dependents.

Sir/Madam,

2. I have been directed to refer to Haryana Government, Health Department letter No.2/24/2013-1HB.III dated 25.08.2014 on the subject mentioned above and to state that the Government has decided to examine the matter again and after careful consideration it has been decided to further liberalize the delegation of powers with respect to Medical Advance and Reimbursement of Medical Claims of Haryana Government employees/pensioners and their dependents which is explained as under:-

a. **Reimbursement of Medical Claim.**

b. **Medical Advance**

Sr. No.	Name Of Office	Power for Medical Reimbursement
1	Head of Office	Rs. 3,00,000/- (Rs.Three Lacs)
2	Head of the Department	Rs. 7,00,000/- (Rs. Seven Lacs)
3	Administrative Department	Full Power

The instructions for sanction of Medical Advance will be applicable as explained in Haryana Government, Health Department letter No.2/24/2013-1HB.III dated 25.08.2014.

3. This decision will be affective from the date of issue of this letter.

4. All the employees/ pensioners/ family pensioners should check the list of private hospitals empanelled by Haryana Government before accessing their treatment as the list is subject to change time to time.

5. This issues with the concurrence of the Finance Department vide their U.O.No.23537-5FD-II/2016 dated 24.08.2016.

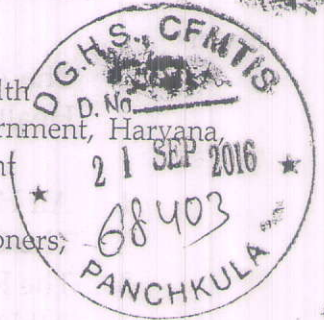
